  - 3.1. FOR DIMENSIONS LESS THAN OR EQUAL TO 125 mm +/- 0.13 mm
  - 3.2. GREATER THAN 125 mm +/- 0.03 mm PER 25 mm
  - 3.3. ANGULAR TOLERANCES; +/- 0.5°
4. MATERIAL: SABIC LEXAN 940A POLYCARBONATE. COLOR TO MATCH RAL 9010. NO REGRIND ALLOWED. NO METALLIC CONTAMINATION IS PERMITTED. CERTIFICATE OF COMPLIANCE MUST BE PROVIDED AT TIME OF SHIPMENT.
5. FINISH: ALL EXTERIOR SURFACES TO BE TEXTURED - MT-11020 (LIGHT TEXTURE). ALL OTHER SURFACE SPI B-3
6. TOOL CONSTRUCTION, GATE, EJECTOR PIN, AND ANY TOOL INSERTS WITNESS LINES TO BE APPROVED BY HOLOGIC.
7. GATE MARKS AND PARTING LINE FLASH TO BE REMOVED TO WITHIN 0.25 mm OF SURFACE. NO SHARP EDGES REMAINING AFTER THE GATE(S) ARE REMOVED (MAX. FINISH 64RMS)

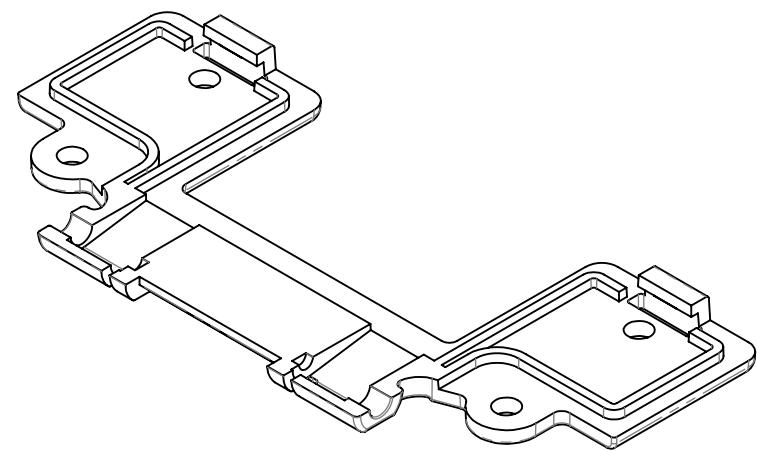


DETAIL C
